



COVID-19 Travel Requirements (as of November 1, 2021)

Your safety and well-being are top priorities at Galina Breeze Hotel. While information continues to evolve regarding COVID-19 regulations, we wanted to give you the most updated requirements for travel to Jamaica and back to the United States and Canada. For information traveling to other countries, please contact us or refer to the country's government website.

TRAVELING TO JAMAICA FROM THE US OR CANADA (Jamaica order effective June 15, indefinitely):

***** All detailed information is available on www.visitjamaica.com. You MUST go to this site! *****

- **TRAVEL AUTHORIZATION FORM:** Within 7 days from trip date, all travelers are REQUIRED to complete and submit a form on the www.visitjamaica.com and print out an APPROVED form. This will be shown to the check-in desk at the airport and the Immigration officer upon arrival to Jamaica.
- **NEGATIVE COVID TEST:** Within 3 days (72 hours) from trip date, all travelers are REQUIRED to be tested for Covid and received a negative result. Positive results will not be allowed to board the plane. All residents of USA (12 years of age or over) will be required to present to the airline check-in desk a negative COVID-19 PCR or Antigen test result that meets the standards of the World Health Organization (WHO) in order to complete check-in for the flight.
- *There is a test calculator on the www.visitjamaica.com site to determine the earliest test date accepted. Tests must be done by a medical laboratory that has a CLIA registration or ISO 15189 certification. Samples collected using home test kits (example: Pixel by LabCorp), along with antibody tests will not be accepted.*

UPON ARRIVING IN JAMAICA:

Galina Breeze Hotel is on the approved list of hotels and resorts on the Resilient Corridor for tourism. You will have already chosen this hotel on the list when you filled out your Travel Authorization Form.

TRAVELING TO THE US OR CANADA FROM JAMAICA (US order effective November 8, 2021, indefinitely)

Before boarding a flight to the United States, you are required to show one of the following:

- **If you are fully vaccinated:** Proof of vaccination and a negative COVID-19 test result taken no more than 3 days before travel.
- **If you are NOT fully vaccinated:** A negative COVID-19 test result taken no more than 1 day before travel.
- Children under 2 years old do not need to test. There is also an option for people who have documented recovery from COVID-19 in the past 90 days. Learn more about these requirements on the link below.
- **Also required:** All air passengers to the United States will also be required to provide contact information to airlines before boarding flights to the United States. More information on this is detailed in the link below.

COVID TESTING IN JAMAICA:

The following will take place for each guest of Galina Breeze (2 years and older) unless you have an officially approved letter confirming you've previously recovered from COVID-19 (see above):

- Galina Breeze has arranged for testing sites on our property through a Jamaican physician's office **within 24 hours** of departure date to satisfy both vaccinated and unvaccinated requirements.
- The test will be a nucleic acid amplification or viral antigen test as required by the CDC.
- The test will cost each traveler \$100US (credit cards accepted).

IN THE EVENT A TRAVELER TESTS POSITIVE BEFORE DEPARTING JAMAICA:

The airlines will *not* let you board the plane with a positive test result. Airline/flight changes will be the responsibility of the traveler. Quarantine accommodations will be made on a case-by-case basis.
